Report Inclusion Criteria: The report includes data for those patients who underwent a joint replacement procedure at [REDACTED] between Jul 1, 2012 and Sep 30, 2012. To be eligible for inclusion in the report, the patient's date of surgery must have been on or between Jul 1, 2012 and Sep 30, 2012 and the patient's data must have been submitted to the CJRR prior to Thursday, February 28th, 2013.

Note: Data for patients who were registered during the reporting period but who did not have surgery during this period is not included in this report (these data will appear in previous or later reports, depending on the patient's date of surgery). Similarly, data for patients who had surgery during the reporting period but for whom data were not yet uploaded to the registry by the time this report was generated are also not included in this report. However, data in this report regarding the number of patients registered does include all the patients who were registered in the CJRR during the reporting period regardless of their date of surgery.

Comorbidities: Comorbidity data reported in the Quarterly Site Benchmark Report (Lagging Quarter) includes all pre-operative comorbidities.

Surgical adverse events: Adverse event data reported in the Quarterly Site Benchmark Report (Lagging Quarter) includes adverse events that occurred within 90 days of surgery, including both perioperative and post-discharge adverse events. Reported adverse events data are confined to those reported by the participating hospital pursuant to inpatient admission or ED visit. The report excludes adverse events that may have been diagnosed in the office or clinic setting only.

Patient Reported Outcomes: Patient reported outcome (PRO) data reported in the Quarterly Site Benchmark Report (Lagging Quarter) includes both pre-operative and three-month post-operative survey collection rates and average scores.

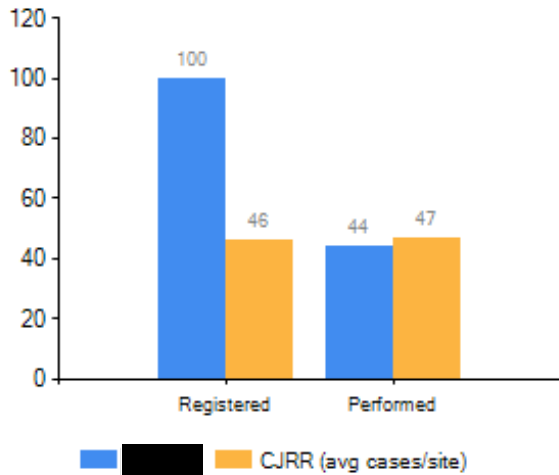

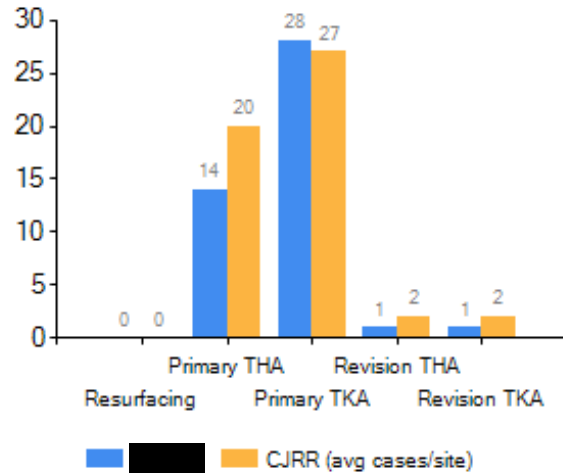

 (Jul 1, 2012 to Sep 30, 2012)

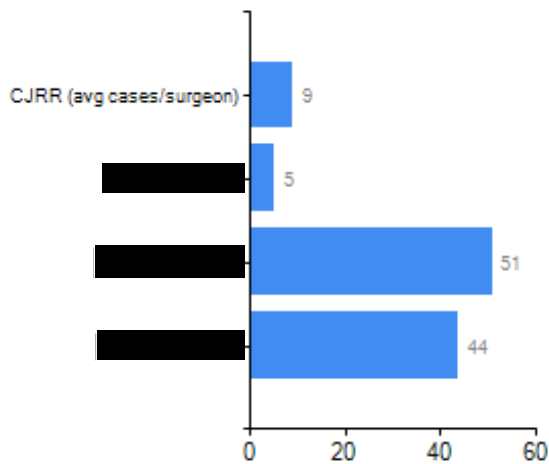


Performed Case Totals by Type
 (Jul 1, 2012 to Sep 30, 2012)

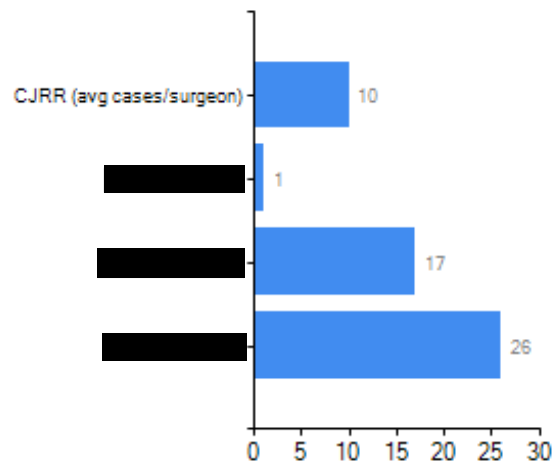

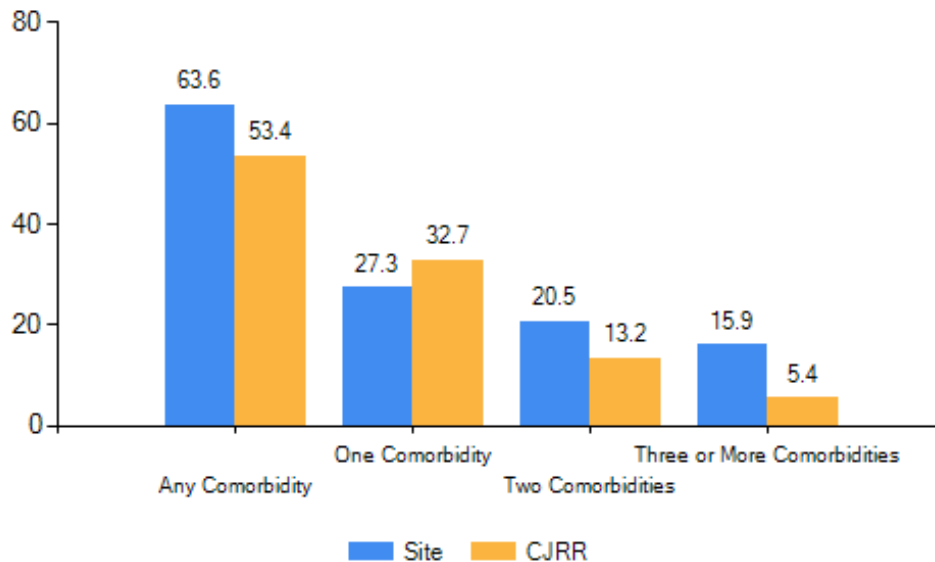

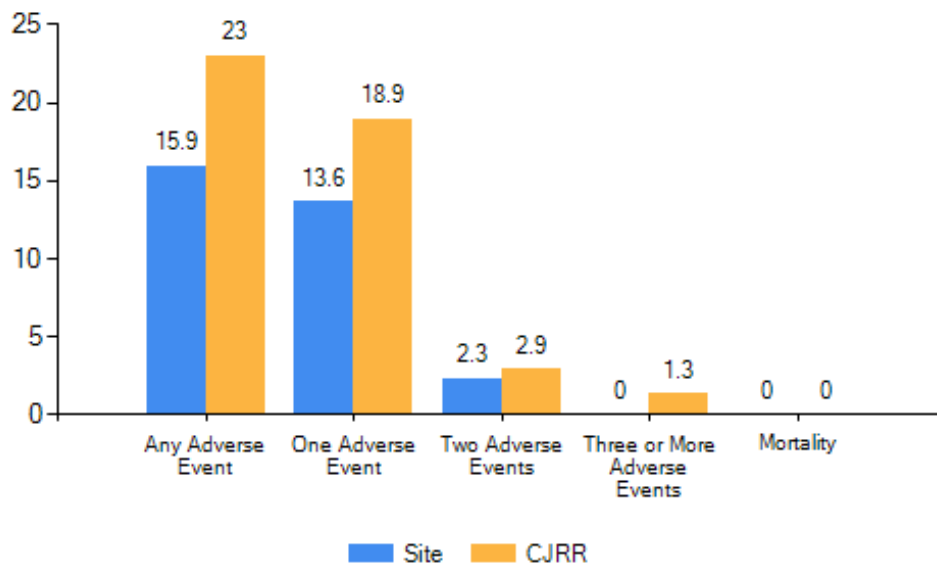

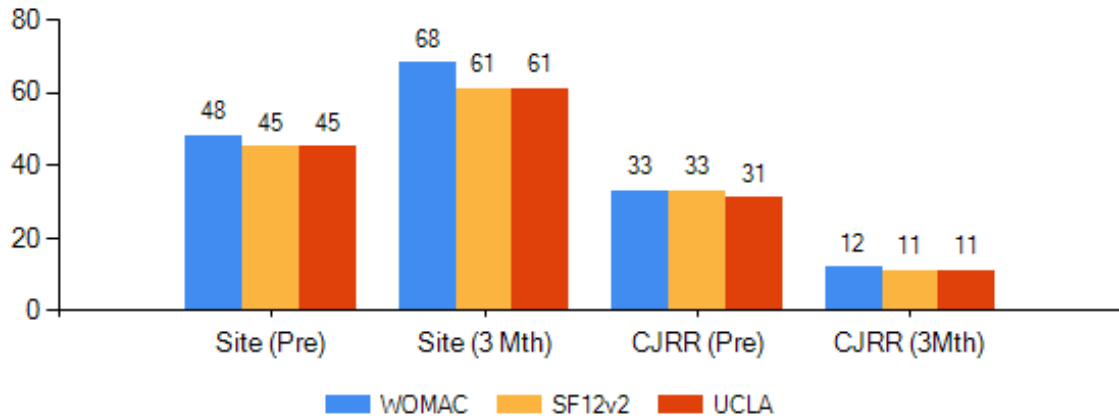

Percentage (%) of Performed Cases with Surgical Complications (Jul 1, 2012 to Sep 30, 2012)

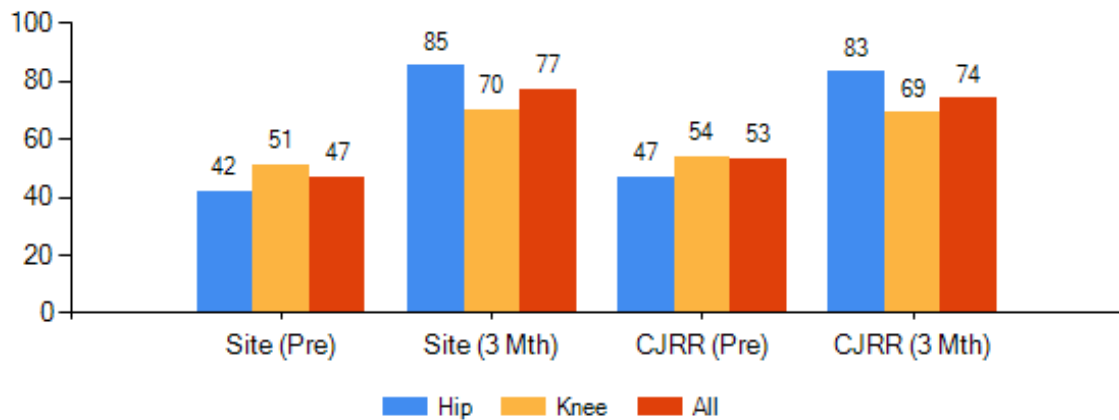




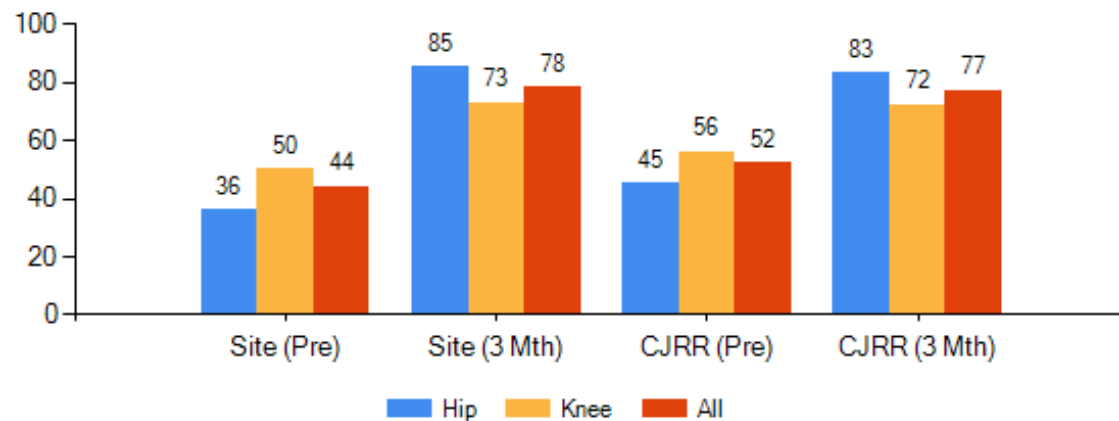
Collection Rate (%) of PROs

(Jul 1, 2012 to Sep 30, 2012)

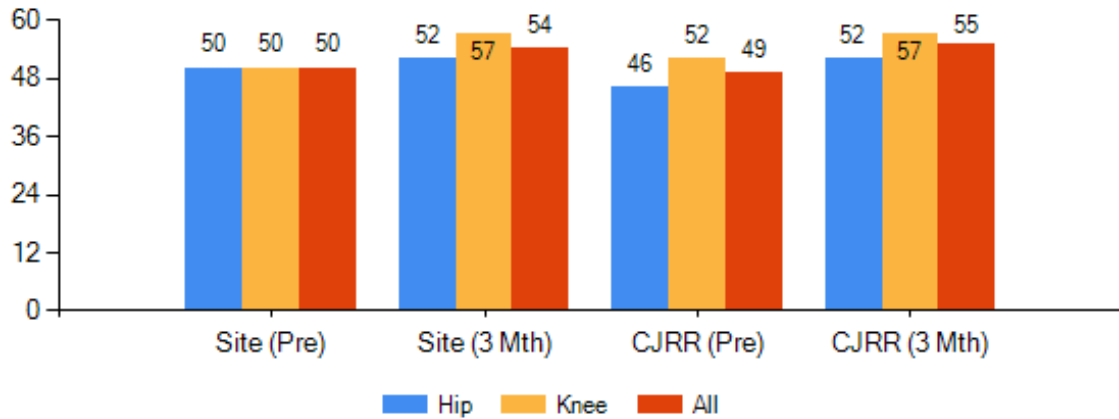


WOMAC Average Function Scores (%)
(Jul 1, 2012 to Sep 30, 2012)

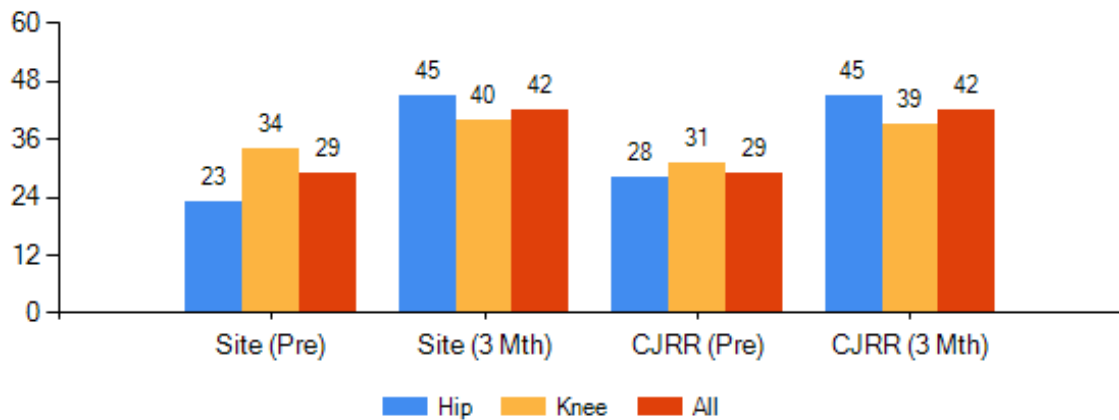




SF12v2 Average Mental Scores
